Exposing Truths of the Murder of Rev. James Reeb

NPR has just released a new Serial podcast about the murder of Unitarian Universalist minister Rev. James Reeb during the Selma campaign of the Civil Rights movement. Rev. Reeb, from Boston, was one of three people murdered during the campaign, the other two being Jimmie Lee Jackson and Viola Liuzzo.

While Jackson, a local African American activist, was not a Unitarian Universalist, both Rev. Reeb and Ms Liuzzo could be considered our first Unitarian Universalist martyrs. Rev. Reeb was a minister working with low-income and marginalized folks in Boston; Viola Liuzzo who is known as a "Detroit housewife" was an activist who didn't hesitate to put her beliefs into action Both felt called to Selma because of their Unitarian Universalist faith.

As you listen to the first episode, which sets the stage for the rest of the series, I encourage you to take advantage of the many resources the UUA has compiled about these events. I especially encourage folks to look into the murder of Viola Liuzzo and its aftermath,

2019 General Assembly Campaign Action

Sign the petition: Close the Homestead Child Detention Center!

The U.S. government is currently holding over 2,000 child migrants, many of whom have been separated from their families by U.S. immigration officials, in a detention center in Homestead, Florida. Most have fled violence and poverty in Central America and are seeking asylum in the United States.

Instead of being released to family members or other sponsors, many are spending weeks or months in inhumane detention. And because Homestead is an emergency influx center, children are not protected by agreements that ordinarily ensure licensing and other standards are met.

What is an "Action of Immediate Witness"?

Each year delegates at the Unitarian Universalist General Assembly have the opportunity to take positions on issues that require immediate witness through the Action of Immediate Witness (AIW) process. An AIW expresses the conscience and carries the authority of the delegates at the GA at which it is passed. AIWs are initiated by individual delegates and move through their entire creation and adoption process during a single GA.

From the 2019 GA:

Action of Immediate Witness passed at the June 2019 General Assembly

RESOLUTION REGARDING IMMIGRATION AND ASYLUM TO THE UNITARIAN UNIVERSALIST ASSOCIATION 2019 GENERAL ASSEMBLY SPOKANE, WASHINGTON

WHEREAS:

- 1. The current administration of the United States Government has systematically and officially prevented immigrants and asylum seekers from crossing our southern border; and
- 2. Whereas, U.S. Government agents have illegally incarcerated immigrants lawfully seeking asylum, and
- 3. Whereas, Long term alien residents have been incarcerated without the opportunity of a legal proceeding, and
- 4. Whereas, Families of U.S. American citizens have been broken up by these unjust actions, and
- 5. Whereas, children have been forcibly taken from their mothers and detained indefinitely, and
- 6. Whereas, Parents have been deported without their children

BE IT RESOLVED

That the Unitarian Universalist Association condemn the policies of The U.S. Government regarding the treatment of immigrants and Asylum seekers, and That the UUA supports its members and others in their actions to Protect and assist immigrants and asylum seekers in their attempts to Lawfully enter and/or remain in the United States, and That the UUA encourages its members to communicate with their Congressional representatives and condemn the policies of the Administration.
